YOU MAY AVOID THE PROPOSED SANCTIONS BY CURING THE VIOLATION WITHIN 7 DAYS OF THE DATE OF THIS NOTICE, AND/OR BY CONTACTING THE HOMEOWNERS ASSOCIATION'S BOARD WITHIN 3 DAYS TO REQUEST AN EXTENSION.

IF A VIOLATION EXISTS WHICH HAS NOT ALREADY BEEN CORRECTED, AND YOU FAIL TO MAKE AN APPROPRIATE CORRECTION, THE ASSOCIATION MAY CORRECT THE VIOLATION AT YOUR EXPENSE.
